Landscaping

Our neighborhood is a beautiful place to live, a place we can be proud of. With the summer months quickly approaching there will be (hopefully) more opportunity for us to walk around and enjoy our neighborhood. We, as a board, would like to ask all of you to prune back the trees around your own homes that are overhanging the sidewalks.

Recently, the board was contacted by the City of Bellingham about four trees on McLeod. They wanted permission to remove the trees because of site line issues. They stated that trees must be trimmed to a height of 8 feet above the sidewalk. Unfortunately, two of the trees may have to be removed because they can not be trimmed to meet this requirement.

Trees between the street and the sidewalk are the homeowner's responsibility. Please maintain them so that in the future we do not

lose any more trees. With that in mind, the board has some recommendations on keeping the trees trimmed.

We would like to see all trees trimmed as follows:

1 foot back from the sidewalk. 8 feet above the sidewalk.

If you would prefer not to maintain the trees in your yard yourselves, on July 15th we will be walking the neighborhood and will at that time be checking and pruning trees to meet the above mentioned guidelines.

Barkley Hill Association

All of you received a flyer from the Barkley Hill Association. Many of you have contacted the board about this issue. First of all, we the board do not endorse this association nor are we working with them. They were founded by a group of individuals to address concerns and improve the community of the Tweed Twenty neighborhood -While we applaud their effort, the board at this time has chosen not to join forces with them. Individual homeowners may at their discretion join this public association. But before you do, I would ask you to become more involved in your own private association as we could use the assistance.

Dues

Stormwater Pond

Currently, the board is seeking bids for work on the stormwater pond. We hope to have someone start work on the pond in July or August if the rain lets up. Recently, the board received some pamphlets from Sarah Jones a Senior Girl Scout in our Association. In the pamphlet, she had some recommendations that we would like to pass on to you.

- Do not discharge toxins into the stormwater system.
- Keep the storm grates clear.
- Keep gutters clear.
- Report street maintenance issues/problems to the county.

CC&R Reminder

Summer is finally here ©, hopefully. Many of us have been waiting along time to enjoy the sun. The board would like to remind you that while it is perfectly acceptable to load or unload your RV or boat; it is not acceptable to leave your RV or boat parked in front of your home for an extended period of time.

Here is a modified version of some of the general use restrictions that are commonly violated:

3.2 Recreational Vehicles. All boats, utility trailers, trucks of more than one-ton rating, campers, recreational vehicles, travel trailers, motor homes and similar items...shall at all times be enclosed

within a garage or otherwise neatly stored behind the front wall line of the residence and reasonably screened from view from the street running in front of said lot...

- 3.6 Garbage/Refuse. No owner shall deposit or permit the accumulation of any such trash, ashes, garbage or other refuse or debris on or about such owner's lot or any other property...except in appropriate covered trash receptacles...
- 3.7 <u>Vehicles</u>. All automobiles and all other permitted vehicles ...shall be in good order and in working condition.

 Partially wrecked vehicles, discarded vehicles, unlicensed vehicles or vehicles which are in a state of disrepair shall not be kept on any lot...
- 3.9 Wire/Chain Link Fences. All wire and/or chain link fences in excess of four (4) feet in height from the ground are prohibited.

In the past, people have questioned what reasonably screened means. An advisory committee was formed to address this issue. Please contact a board member if you have questions or wish to contact this committee.
