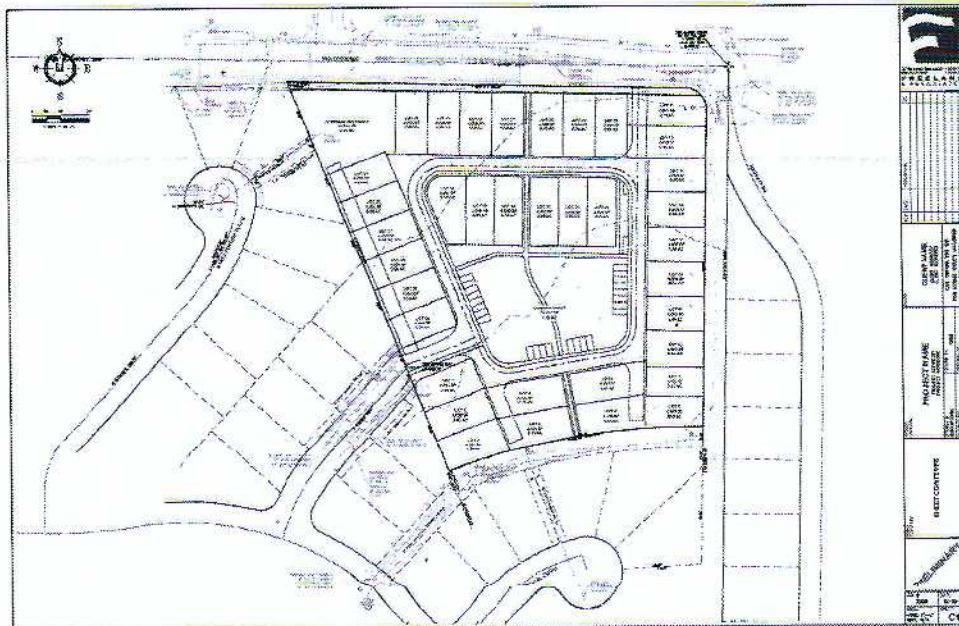

When it is your turn to speak your microphone will be unmuted and we will call on you for your name and comment.
